- Have been in contact with someone with COVID-19 in the last 14 days.
- If you have a serious underlying health condition, including high blood pressure, chronic lung disease, diabetes, obesity, asthma, or whose immune system is compromised parental discretion for participation will be advised

The lead instructor is Dina Bogosian who has coached high school field hockey and has been with North Kingstown recreation for NINE exciting years.

Benefits of this program are plenty of exercise, improved eye-hand coordination, fun, and will learn the skills needed to play at the High School level. NK is consistently one of the most successful teams in RI winning the state championship several times in the last twenty years.

Due to the current situation with COVID our 6-8th grade program will not be competing against other towns/schools this year. We will be focusing on field hockey techniques, skills, and game rules. The instruction will continue to prepare the players for high school level field hockey.

The fee to participate is \$90 resident \$99 non-resident which includes a mouthpiece and t-shirt. We provide sticks, balls and goggles. Please send your child with Shin Guards and water. Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact.
