

GIRL'S LITTLE LEAGUE SOFTBALL SIGN-UP

Recreation has four leagues for the Girls, All home games and practices are at Ryan Park on Oak Hill Road:
Leagues are combined with Surrounding Communities, TBD depending on COVID-19 Restrictions.

No experience necessary for any level, limited away games, transportation will not be provided to away games. We will be following all state recommendation for COVID-19 at the time the season begins.

Age cutoff is January 1st. If a player turns 13 after January 1st 2021, she is considered 12 for this season

- **Juniors League for 12-14 year olds.** Games will be on Tuesdays and Thursdays at 6 PM.. On occasion there will be a 7 PM game.
- **Majors League for 9-12 year olds.** Games will be on Tuesday and Thursday at 6 PM. On occasion there will be a 7 PM game.
- **Minor League for 8-11 years old** for those new to the sport or who may not feel ready to play in the Majors. Games will be on Mondays and Wednesdays at 6 PM.
- **Coach Pitch for 5 to 8 year olds** who want to get started, They will play on Mondays and Wednesdays at 5:30 PM.

Coaches Needed at All levels

Optional Practice Clinics will start indoors before we can get on fields, Coach Pitch level will be Tuesdays in March, Minors, Majors & Juniors will be Sundays. We will continue in the gyms until the fields are ready for the season. Coaches, NKHS players, and Travel team players will coach the kids in drills and skills to get them ready indoors. Once the weather turns, we will move onto the field. Season runs from Late April to Mid-June, Game schedule will be announced as season opening approaches. We do our best to stick to above days and times for each division but occasionally there may be an adjustment. Our Free Indoor practices requires additional registration online, spots are limited. Sneakers only in the gym.

We at NK Rec take your health and safety very seriously. We will be abiding by the State COVID Guidelines that are subject to change. Masks are now required for participants, coaches and volunteers over the age of 2. Please bring hand sanitizer. There will be a screening at drop off, in some cases, including temperature taking, please allow yourself an extra few minutes. If you answer YES to any screening questions or you have a temperature you will not be allowed to participate that day. At this time we are allowing minimal and in most cases no spectators. Athletes are recommended to get weekly COVID-19 tests. If you have tested positive or recently been in contact with a positive case inform your coach immediately. If you have a serious underlying health condition, including high blood pressure, chronic lung disease, diabetes, obesity, asthma, or whose immune system is compromised discretion for participation will be advised. MINOR'S CONSENT TO PARTICIPATE
AND HOLD HARMLESS AGREEMENT AND RELEASE**

The minor's parent(s) or guardian(s) understand that participation in the above event or program is VOLUNTARY and that the minor does not have to participate. It is understood that the event or program involves activities which could result in injury to the minor's person or damage to the minor's property, and that by participating, the minor's parent(s) or guardian(s) voluntarily accept and assume the risk of injury to the minor or damage to the minor's property and consent the minor's participation in the event or program.

It is understood that the Recreation Department DOES NOT provide any insurance coverage for the minor's person or property; and minor's parent(s) or guardian(s) acknowledge that they are responsible for the minor's safety and the minor's own health care needs, and for the protection of the minor's property.

In exchange for allowing the minor to participate in this event or program, the minor by and through the undersigned, agrees to release from liability, indemnify, and hold harmless the Town of North Kingstown, its agents, officers, and employees for any injury to the minor's person or damage to the minor's property which arises out of or occurs during or as a consequence of the minor's participation in the event or program, whether or not such injury or damage may have been caused, in whole or in part, by any negligence or want or care on the part of the Town of North Kingstown, its agents, officers, or employees.

This Hold Harmless Agreement and Release shall be binding upon the minor, the parent(s) or guardian(s), any successors in interest, and/or any person(s) suing on the minor's behalf.

The minor's parent(s) or guardian(s) understand that this document is complete unto itself and that any oral promises or representations made to them concerning this document and/or its terms are not binding upon the Town of North Kingstown, its officers, agents and/or employees.

PARENT OR LEGAL GUARDIAN MUST SIGN BELOW:

I, the undersigned, state that I am the parent or legal guardian of the minor whose name appears above. I understand that the above terms and conditions apply to said minor and to myself. I further understand that said minor cannot participate under ANY circumstances in the above specified event or program without parental consent and that the minor will not be allowed to participate without entering into this agreement. Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact.
